JOB TITLE: Finance Officer - Purchase Ledger

REPORTS TO: Purchase Ledger Manager

Salary: Support Pay Scale

JOB PURPOSE: As a Finance Officer – Purchase Ledger, you will play a vital

role in managing the financial records of our college. Your responsibilities will primarily focus on maintaining accurate purchase ledger records, processing Supplier invoices, and outgoing payments in compliance with the college financial policies and procedures. You will work closely with the related stakeholders to ensure that suppliers are paid promptly and

efficiently.

NB This job description is current at the date of issue. It will be reviewed annually and may by updated by the principal.

Purchase Ledger Responsibilities:

To control and manage Supplier Accounts on Purchase Ledger to include: -

- 1. Processing purchase invoices against purchase orders.
- 2. Chasing GRN's.
- 3. Processing non-PO invoices.
- 4. Accurately post supplier invoices and credit notes carefully checking for duplicates on the accounting system in a timely manner.
- 5. Pursue invoice and purchase order queries promptly to avoid delays in processing.
- 6. Understand expense accounts and cost centres.
- 7. Processing manual payments.
- 8. Assist with supplier payment runs, as required.
- 9. Verification of new supplier set-ups and modification of existing supplier details.
- 10. Assist with direct debit payment allocation onto the general ledger, as required.
- 11. Assist with remittances, as required.
- 12. Purchase ledger journals, as required.
- 13. Supplier statement reconciliations.
- 14. Effective daily management of the finance inbox.
- 15. Respond to supplier and colleagues' queries in an appropriate and timely manner.

Other duties:

16. Assist with month end close process in managers absence ensuring that monthly reconciliation of Balance Sheet control account is carried out in compliance with college internal policies and procedures.



- 17. Assist with year-end audit.
- 18. Assist with providing analysis and reconciling of general ledger accounts, as required.
- 19. Resolve accounting or documentation issues and discrepancies as they arise.
- 20. Assist with other accounting matters as and when required.
- 21. Participate in special projects and miscellaneous assignments, as required.
- 22. To provide excellent customer service, manage and maintain good relationship with the internal and external stakeholders.
- 23. Any other support as required across the college.

NOTE

The post will be based at one of the current College campuses, but the duties of the job may require the post holder to work at any College campus or other location connected with the work of the College. Travel between the college's main campuses will form a requisite part of this post.
