### **The main duties and responsibilities of the post include the following: -**

1. Effective delivery of a teaching programme within the areas of competence of the post holder, paying due regard to developing independent learners, and enabling student progression towards successful completion
2. Develop ways of working that are responsive to learners' needs, monitor and evaluate progress and practice and prepare learners for examinations.
3. To promote and facilitate high levels of student attendance, retention and achievement.
4. Provide accurate and timely data and information, including registers, withdrawals and transfers, assessments, examination details and progress reports.
5. Attend and contribute to curriculum team meetings and student success meetings etc. as required.
6. To contribute to the assessment of learners, from application through to progression and to inform appropriate placing on course including the setting of targets, milestones and provision of support.
7. Draw up confidential ILPs and learner profiles on the ILP, outlining individual strengths and areas for development, agreeing targets and milestones with learners and subject teachers, contribute to their review and updating throughout the year.
8. Keep up to date in relevant areas of professional expertise through research; attendance at meetings and relevant training; membership of networks as appropriate.
9. Maintain student morale and discipline inside and outside "the classroom" within the College sites and in conjunction with College management.
10. Support the organisation of extra-curricular activities necessary to the student's career and personal development.



11. Attendance at relevant parents/open evenings.
12. Any other duties commensurate with the grading of this post as may be required from time to time.

**NOTE**

The post may be based at one of the current College campuses, but the duties of the job may require the post holder to work at any College campus or other location connected with the work of the College. Travel between the college's main campuses will form a requisite part of this post.
